K.C. Electric Association will award and/or administer the awards to the following:

- (two)-\$1,000 Scholarships from K.C. Electric Association
- (three)-\$750 Scholarships from K.C. Electric Association
- (one)-\$1,000 Scholarship from Basin Power Cooperative
- (two)-\$500 Scholarships from Tri-State Generation & Transmission Association

By filling out and submitting this application you are automatically applying for all scholarships listed above. **Note: If you are eligible for a K.C. Electric scholarship, you are eligible for the Basin and Tri-State scholarships. Only one application is required.**

These scholarships will be awarded to graduating high school seniors planning to attend accredited colleges, universities, junior colleges, community colleges or trade schools. Students must enter college the same year as their graduation from high school. This award may be given in addition to other grants and scholarships. The recipient will be chosen by a review panel. The award will be paid jointly to the student and the school the student attends. The student must be classified as a full-time student and confirmation of enrollment is required.

ELIGIBILITY AND APPLICATION REQUIREMENTS

- A parent or legal guardian must be receiving electric service from K.C. Electric Association.
- A cumulative Grade Point Average (GPA) of at least 2.5
- One photo of student- preferably not printed or scanned version, actual glossy photo
- The applicant must use K.C. Electric's scholarship form.
- A notarized high school transcript must accompany the application
- One letter of recommendation from a counselor, teacher, or former employer
- Complete an essay below-

2022 ESSAY QUESTION:

How will the existing Colorado greenhouse gas reduction laws affect your use, reliability and cost of electricity in the next ten years?

- The essay should be no more than one page, typed with a font size no smaller than 12 pt., and double spaced on 8 ½ x 11 paper. (About 400 words)
- Include your name on the top right-hand corner of the essay.
- The scholarship application must be received by K.C. Electric Association no later than **Thursday, February 9, 2023 -5:30 p.m.**
- **(Partial or Late Applications will not be eligible or considered after deadline. NO EXCEPTIONS.)**
